Hall Announces Bid for Georgia Senate District 50

MOUNT AIRY, Georgia – Habersham County Commission Chairman Stacy Hall has announced his intention to seek the office of Georgia State Senate representing District 50. “Our North Georgia way of life is under attack. While representing District 50, I plan to fight for our conservative values and constitutional rights. I will work tirelessly under the Gold Dome to protect our 2nd Amendment constitutional right to keep and bear arms. I will not waiver in my effort to protect the unborn, and I will stand firm for religious liberty. I will work closely with our agricultural community to ensure that our number one industry not only survives but thrives, and I will seek smart, strategically planned industrial growth so that we have plenty of well-paying jobs.” True to this commitment, earlier this month Hall led discussions on the county commission that culminated with Habersham County being the first 2nd Amendment Sanctuary county in the state of Georgia.

Hall recently announced that he would not seek re-election to the Habersham County Commission citing one of the reasons to spend more time with his family. “Although interested, I had not originally planned to run for this office at this time. However, after overwhelming support and encouragement throughout the district as well as much prayer and discussion with my family, it was clear that I needed to pursue this office to protect our North Georgia values in Atlanta. It is only with the full support of my family that I am running. I want to model for my children the privilege of serving others. I feel that my experience, my passion, and my values will be an asset to the people I represent,” said Hall.

A republican, Hall is currently in his second year as Chairman of the Habersham County Board of Commissioners. He also currently serves on the Fellowship of Christian Athletes local advisory board and the Presidential Advisory Board at Tallulah Falls School. He is a member of the NRA and Georgia Carry, is active with the Habersham Partnership for Growth, and he and his family are members of Level Grove Baptist Church. He has served as Chairman of the Habersham County Hospital Authority, Chairman of the White County Chamber of Commerce, board member for Habersham United Way, and Vice Chair for Fellowship of Christian Athletes. Hall is a graduate of Leadership Georgia, Leadership Habersham, and the Georgia Academy for Economic Development.

Professionally, Hall and his wife, Ivy, own a real estate development business. He was the athletic director and a business professor for Truett McConnell University for 5 ½ years. Prior to that, he worked as a sports marketing executive in college sports for 21 years with his last stint being a Vice President for IMG College overseeing sales operations for eleven Southeastern Conference schools. Hall is an experienced educator having taught on every level of education – elementary, middle, and high school as well as undergraduate and graduate level college classes.

Senate District 50 includes all of Banks, Franklin, Habersham, Rabun, Stephens, Towns, and parts of Hall and Jackson counties. Hall plans to complete his term as commissioner which ends December of this year.
