ARTICLES OF INCORPORATION

ARTICLE ONE  
NAME

The name of the corporation is BARROW COUNTY METHAMPHETAMINE  
TASK FORCE, Inc. (hereinafter, the "Corporation.")

ARTICLE TWO  
ORGANIZATION PURSUANT TO THE GEORGIA NONPROFIT CORPORATION  
CODE AND 26 U.S.C. § 501(c)(3)

The corporation is organized pursuant to the Georgia Nonprofit Corporation  
Code, O.C.G.A. § 14-3-101, *et seq.*, and 26 U.S.C. § 501(c)(3) of the Internal Revenue  
Code (the "Code"), or the corresponding section of any federal tax code enacted in the  
future.

ARTICLE THREE  
PURPOSES OF THE CORPORATION

The Corporation is organized and shall operate exclusively and permanently for  
charitable purposes within the meaning of 26 U.S.C. § 501(c)(3) of the Code, with said  
purposes to include the following:

To provide and assist with education, prevention, and treatment of those  
individuals in the Barrow County, Georgia community affected by methamphetamine use  
and abuse;

To make and perform contracts of every kind for any lawful purpose without limit  
as to amount, with any person, firm, association, corporation, municipality, state or other  
political entity or subdivision; and

To have and exercise all the rights and powers conferred upon nonprofit corporations under the laws of the State of Georgia.

All assets of the Corporation shall be dedicated to the purposes stated above.

ARTICLE FOUR  
ACTIVITIES OF THE CORPORATION

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, to such extent as would result in loss of its exemption from federal income tax liability under section 501 of the Code, and the Corporation shall not participate or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code, or the corresponding section of any future federal tax code.

ARTICLE FIVE  
DISTRIBUTION OF INCOME OR PROFIT

The Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the income, property, earnings, or profits of the Corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to make distributions in furtherance of the purposes set forth in Article Three above.

ARTICLE SIX  
MEMBERS AND OFFICERS

The Corporation shall have members and officers.

ARTICLE SEVEN  
INITIAL REGISTERED OFFICE AND AGENT

The street address of the registered office is 30 North Broad Street, Winder, Georgia 30680. The registered agent at such address is Murray Kogod. The County of the registered office is Barrow County, Georgia.

ARTICLE EIGHT  
INITIAL PRINCIPAL OFFICE

The address of the initial principal office of the Corporation is 30 North Broad Street, Winder, Georgia 30680.

ARTICLE TEN  
LIMITATION OF DIRECTOR LIABILITY

No Director of this Corporation shall be personally liable to the Corporation or its members for monetary damages for breach of fiduciary duty as a Director except for liability (i) for any appropriation, in violation of his duties, of any business opportunity of the Corporation, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) for the type of liability set forth under

Section 14-3-831 of the Georgia Nonprofit Corporation Code, or (iv) for any transaction from which the Director received an improper personal benefit.


If the Georgia Nonprofit Corporation Code is hereafter amended to authorize the further elimination or limitation of the liability of a Director then the liability of a Director of the Corporation shall be eliminated or limited to the fullest extent permitted by the Georgia Nonprofit Corporation Code, as so amended. The provisions of this Article shall not be deemed to limit or preclude indemnification of a Director by the Corporation for any liability of a Director, which has not been eliminated by the provisions of this Article.


ARTICLE ELEVEN  
DISSOLUTION

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is located at the time of dissolution, exclusively for such purposes or to such organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
